 - c) During the remote e-voting period, the Members of the Company holding shares either in physical form or in dematerialised form, as on the cut-off date of 18th August, 2026, may cast their vote electronically. Once the vote on the resolution is cast by the Member, the Member shall not be allowed to change it subsequently.
 - d) The Company has engaged CDSL to offer remote e-voting facility to all the Members to enable them to cast their vote electronically.
 - e) Voting rights shall be reckoned on the paid-up value of shares registered in the name of the Member/ Beneficial Owner (in case of shares held in dematerialised form) as on the cut-off date i.e., 18th August, 2026.  - (ii) Shareholders who have already voted prior to the Meeting date would not be entitled to vote at the meeting venue.

- (iii) Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020, under Regulation 44 of the Listing Regulations, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed by SEBI that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided by SEBI to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

- (iv) In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

BOARD'S REPORT

REVIEW OF FINANCIAL PERFORMANCE AND STATE OF COMPANY'S AFFAIRS

During the year under review, the Company continued its focus on value-added products under the Manufacturing Division and on profitable operations at site level in respect of the Services and Operation and Maintenance Division. The Company continued to invest in strengthening its commercial and operational efficiencies, by onboarding additional talent across key functions. This enabled the Company to register reasonable growth in turnover and marginal growth in profitability at the standalone level. At the consolidated level, profitability was impacted during the year despite an increase in revenues, primarily on account of the ongoing geopolitical situation in the Middle East and loss at our subsidiary in Saudi Arabia, driven by a combination of reduced income and higher expenses on account of increased investments in manpower and workshop facilities during the year. The financial performance of the Company at standalone and consolidated levels are given below.

STANDALONE

Your Company recorded revenue (from operations) of ₹ 51,421.42 lakhs for the year ended 31st March, 2026 as against ₹ 43,645.79 lakhs in the previous year. It achieved an EBITDA of ₹ 8,869.54 lakhs (previous year ₹ 8,584.51 lakhs), resulting in a net profit of ₹ 5,514.20 lakhs as against ₹ 5,000.57 lakhs in 2024-25, registering a growth of 3.32% in terms of EBITDA and 10.27% in terms of net profit.

CONSOLIDATED

The Consolidated Financial Statements of the Company have been prepared as per Ind-AS 110. The Company's consolidated revenue from operations in the year under review aggregated ₹ 63,208.65 lakhs (previous year ₹ 55,273.55 lakhs) on which it made EBITDA of ₹ 8,968.01 lakhs (previous year ₹ 9,275.78 lakhs) and net profit (attributable to the Owners of the Company) of ₹ 4,925.95 lakhs as against ₹ 4,989.37 lakhs in 2024-25, registering a decline of 3.32% and 1.27% in terms of EBITDA and net profit (attributable to the Owners of the Company), respectively.

DIVIDEND

The Board of Directors is pleased to recommend payment of dividend of 50% i.e., ₹ 5/- per equity share of ₹ 10/- each for the Financial Year ended 31st March, 2026 (previous year: 50%). Based on the equity shares outstanding as on 31st March, 2026, the dividend would absorb an amount of ₹ 542.37 lakhs (previous year - ₹ 542.30 lakhs). The dividend income will be taxable in the hands of the Shareholders at the rates prescribed in the Income-tax Act, 2025. The dividend payment is subject to the approval of the Members at the ensuing Annual General Meeting.

EMPLOYEES STOCK OPTION SCHEME

The Members of the Company at their 29th Annual General Meeting held on 26th August, 2015 had approved the Thejo Employees Stock Option Scheme 2015 ("ESOP 2015"), with a view to attract and retain the best talent and promote increased participation by the employees in the growth of the Company.

The Compensation / Nomination and Remuneration Committee of the Board *inter alia* administers and monitors the ESOP 2015.

During the year under review, there were no material changes in the ESOP 2015 and the Scheme is in compliance with the SEBI Regulations on ESOPs.

REPORT ON MANAGEMENT DISCUSSION AND ANALYSIS

GLOBAL ENVIRONMENT

During FY26, the global economy faced several headwinds, including trade policy shifts and rising geopolitical tensions. Early in the year, new U.S. tariffs increased uncertainty, yet global activity remained resilient. IMF estimates initially projected global GDP growth of 3.3% in 2026 and 3.2% in 2027, with inflation easing to 3.8%. However, the late-February 2026 Middle East conflict disrupted energy markets and shipping routes, pushing oil prices up more than 21% and lifting global inflation to about 4.4%. Growth for 2026 was revised downward to 3.1%, with energy-importing emerging markets most affected. Still, structural supports persist: advanced economies are expected to grow 1.8%, AI-driven investment remains strong, and trade volumes are likely to recover gradually. Global growth is projected to stabilize near 3.2% in 2027, assuming energy markets normalize and geopolitical risks ease. Productivity gains from AI, stable domestic demand, and reduced trade uncertainty underpin the outlook, though risks remain skewed downward, with adverse scenarios pulling growth downwards. India

India remained one of the fastest-growing major economies, supported by strong domestic demand, resilient services exports, and sustained public investment. GDP is estimated at 7.3% in 2025 and revised to 7.6% for 2026, with growth moderating to 6.4–6.5% over 2026-27 but still above global averages. Inflation is projected to ease from 4.7% in 2026 to 4.0% in 2027, and unemployment remains stable near 4.9%. The 2026 Middle East conflict raised external risks, widening the current account deficit, though strong remittances and competitive services exports offer support. Despite global uncertainties, India's medium-term outlook remains favourable, driven by investment, digital adoption, infrastructure expansion, and ongoing reforms, keeping growth above 6.5%. (Source: IMF January 2026, IMF April 2026)

Australia

Australia's economy is undergoing a managed soft landing, with growth slowing to about 1.8% in 2025 and inflation easing toward 2.7% by 2026. Household spending remains weak due to high interest rates and subdued real income growth, though the labour market remains resilient combined with unemployment. Structural challenges, falling productivity, housing affordability pressures, and a budget deficit of about 3.4% of GDP continue to constrain the medium-term outlook. Growth is expected to improve as real incomes recover and financial conditions ease, supporting inflation's return to target. However, risks from weak productivity, housing supply imbalances, and global uncertainty persist, making long-term performance reliant on effective reforms that boost productivity, expand housing supply, and strengthen fiscal resilience.

Australia's mining sector remains a key driver of exports, investment, and fiscal revenues, supported by strong global demand for iron ore, coal, LNG, and emerging critical minerals. While resource exports have bolstered economic resilience amid soft domestic demand, mining investment has eased as the industry shifts to stable production. The sector now faces rising costs, capacity constraints, and commodity price volatility, requiring continued investment and policy support. (Source: OECD)

Our subsidiary in Australia, Thejo Australia Pty Ltd was impacted due to the above factors in the recent past. However, the economic environment is expected to improve in the near future.

Saudi Arabia

The International Monetary Fund (IMF) projects Saudi Arabia's economy to grow by approximately 3.1% in 2026, reflecting a downward revision from earlier expectations due to regional geopolitical disruptions affecting energy production and transportation. Despite these pressures, Saudi Arabia is expected to remain among the least impacted Gulf economies, supported by alternative export routes and relative structural resilience. The IMF has revised the Kingdom's 2027 growth forecast upward to 4.5%, assuming a normalization of energy output and transport activity. At the regional level, growth in the Middle East and North Africa is projected to slow in 2026 before recovering in 2027, contingent on improved stability. Overall, while near-term growth is moderated, the medium-term outlook for Saudi Arabia remains constructive, subject to geopolitical developments. (Source: Argaam)

On the back of the investments made by the Company in terms of manpower and workshop facilities, Thejo Hatcon Industrial Services Company is expected to effectively leverage emerging business opportunities to accelerate growth.

Brazil

Brazil's economy grew about 3.4% in 2024, supported by strong consumption, better labour market conditions, and rising investment. Momentum softened in 2025 as high interest rates, elevated inflation near 5.2%, and tighter financial conditions weakened demand. Household debt servicing costs rose, further pressuring spending. With inflation above target and fiscal constraints limiting support, sentiment and private investment have cooled. Growth is expected to remain moderate until monetary conditions ease, with a gradual recovery from 2026 as inflation falls and consumption improves, though risks from inflation, fiscal pressures, and global uncertainty persist.

Brazil's mining sector is driven by strong iron ore output and demand from global steel markets, especially China, with iron ore accounting for over half of revenues and most exports. The steel industry remains closely linked to mining, supporting construction and manufacturing. While the sector faces trade risks, cost pressures, and decarbonisation demands, growth prospects remain supported by solid iron ore fundamentals and emerging critical minerals, with Thejo Brasil expecting positive traction ahead.

BOARD'S REPORT

Chile

Chile's growth is expected to ease to around 2.4% in 2026 amid fiscal adjustments and global uncertainty, though overall stability persists. The mining sector remains central to investment, with Chile maintaining its global leadership in copper and expanding its lithium capacity. The investments and ongoing reforms support medium-term growth fundamentals, and our Chilean subsidiary, Thejo Engineering Latino America SpA, is expected to capitalise opportunity and move towards growth targets.

United Arab Emirates (UAE)

The UAE economy remained resilient and continued to expand, supported by diversification efforts, strong policies, and a stable financial system. Growth was projected at 5.6% in 2026, driven mainly by robust non oil sectors such as trade, logistics, tourism, manufacturing, construction, and financial services. Continued momentum in non-oil industries, a favourable investment climate, and digital and structural reforms were expected to sustain growth. However, the recent geo-political conditions have dragged the momentum in the near term. Our subsidiary, TE Global FZ LLC in Ras Al Khaimah, continues building its customer base with strict cost controls and is poised to take swift decisions based on emerging situations/opportunities.

In the light of prevailing geo-political tensions and global trade disruptions, our subsidiaries remain focussed at long term growth through sustainable business practices.

INDUSTRY STRUCTURE AND DEVELOPMENT

The Company offers various products and services that predominantly caters to Bulk Material Handling and Mineral Processing activities. The business prospects of the Company are closely tied to these activities/ industries.

Material Handling & Conveyor Systems

Conveyors remain central, forming the backbone of automated facilities and playing a critical role in mining, where the conveyor belt market is projected to grow to USD 2.44 billion by 2031 as the industry shifts toward continuous, lower-emission material transport. Asia Pacific leads adoption, supported by large-scale manufacturing and logistics expansion, with North America and Europe upgrading legacy systems. India is emerging as a fast-growing market, with its automated systems expanding rapidly, driven by warehouse automation, smart factories, and mining-sector conveyor usage. Overall, strong automation uptake, digital integration, and industrial expansion position conveyors and material handling systems for sustained global growth.

Mineral Processing

The mineral processing market is expected to grow rapidly, supported by steady demand for processed metals, expanding mining activity, and greater use of advanced, efficiency-enhancing equipment. India's push for domestic mining, value addition, and reduced raw-export reliance is accelerating capacity growth, while global demand for critical and battery minerals strengthens long-term prospects. The sector faces energy-intensive operations, declining ore grades, and tighter environmental regulations, prompting increased adoption of energy-efficient systems, automation, and water-recycling technologies. Overall, the market remains structurally strong, aided by technology upgrades, beneficiation of low-grade ores, and continued policy and infrastructure support.

BOARD'S REPORT

Industrial Services market

The Industrial Services market continues to grow, driven by rising industrial activity and the need for reliable, efficiency-focused maintenance and optimization solutions. The global market is projected to expand supported by wider adoption of IoT-enabled monitoring, predictive maintenance, and remote diagnostics. Companies are responding to operational complexity, aging assets, and stricter regulations by investing in advanced diagnostics and energy-efficient practices. Despite cost pressures and supply chain challenges, the outlook remains positive, reinforced by industrial modernization, sustainability requirements, and increasing demand for outsourced, digitally enabled service models.

COMPANY PROFILE AND KEY DEVELOPMENTS

Profile

Thejo Engineering Limited is a premium engineering solution provider to mining, mineral processing and bulk material handling industries through manufacturing products, and offering onsite maintenance through technical as well as operations and maintenance services. The Company serves a variety of industries like steel, mining, mineral processing, aggregates and sand, power, chemical and fertiliser, cement, ports, etc. The products business of the Company centres around design, development, manufacture and supply of rubber and polyurethane-based engineered products for belt cleaning, spillage control, flow enhancement, impact and abrasion protection, and screening applications. Thejo Engineering is one of the few companies in the sub-continent offering manufacturing, marketing, and servicing activities under one roof.

Thejo Engineering was listed in the SME-EMERGE platform of the National Stock Exchange of India Limited (NSE) in 2012 and migrated to the Main Board (Capital Market Segment) of NSE in 2023. The Company has global presence with subsidiaries in Australia, Saudi Arabia, Brazil, Chile and Ras Al-Khaimah, UAE. The Company caters to India, Australasia, Middle East, South America, North America, Sub-Sahara and West Africa markets. The Company has manufacturing facilities and in-house R&D Centre in Chennai. The Company has distributor networks in various geographies. The Company has been focussing on expansion activities, as part of which, has approved the second phase of expansion of its manufacturing facilities at estimated capex of about ₹ 40 Crore, to be completed during FY 2026-27.

RESEARCH AND DEVELOPMENT

The R&D Centre of the Company is focusing on developing new and innovative products, as well as bringing about continuous improvement of existing products to meet the needs of customers and tap into new markets. One of the primary functions of the centre is to spearhead innovation through researching and developing new techniques, equipment, and processes aimed at improving efficiency, reducing environmental impact, and enhancing safety in operations. The focus is on developing sustainable practices and technologies to mitigate environmental impact. The sustained efforts of the R&D Team have helped the Company to develop diverse product ranges capable of withstanding some of the hardest working conditions in core sector industries.

During the year under review, the Company had applied for patents in respect of several products/inventions. As at the end of the financial year, the Company had applied for 48 product patents and three design protections, of which 28 product patents and the three design protections have been awarded and the balance are in process.

Collaboration with industry stakeholders, academia, and government agencies is integral to the functioning of the R&D centre. By fostering partnerships and sharing knowledge, the centre is engaging in collaborative basic research projects with academic universities.

BOARD'S REPORT

SAFETY

As part of its policy of giving utmost importance to safety, the Safety Department of your Company is continuously evaluating every process at its manufacturing as well as work sites and taking necessary steps for the safety of personnel as well as of properties. The Company conducts safety reviews on regular basis and takes appropriate steps based on the findings.

The Company has its Excellence Centre to train the technicians of the Company on safety and various technical aspects of the job. Safety, quality and speed are key to our services business.

OPPORTUNITIES AND THREATS

Opportunities

Thejo Engineering is expected to benefit from positive structural trends across mining, material handling, and industrial services. Global mining investment is strengthening, supported by sustained demand for iron ore, coal, and battery minerals essential to the energy transition. This drive increased requirements for conveyor systems, wear-protection solutions, and high-reliability maintenance which are the core strengths of the Company. India's rapid industrial expansion, automation adoption, and policy support for domestic mining and infrastructure development create major opportunities across material handling, splicing, and engineered service offerings. The accelerated shift towards automated warehouses, IPCC-driven mining operations, and digitally enabled asset-management systems further expands long-term demand for technologically advanced and service-centric solutions. Additionally, tightening environmental norms globally are prompting customers to adopt energy-efficient, safer, and more sustainable handling systems, providing scope for Thejo to scale high-value, differentiated offerings. The Company's growing presence in Australia, the Middle East, and Latin America strengthens its access to attractive mining markets and positions it to capture larger service contracts and recurring aftermarket opportunities. These multi-regional growth drivers create a strong pipeline for long-term expansion.

Threats

Thejo Engineering operates in markets that remain sensitive to global macroeconomic and commodity-cycle risks. Heightened geopolitical tensions, such as the 2026 Middle East conflict, have increased volatility in energy prices, shipping routes, and financial markets, potentially affecting mining investment cycles and cost structures. Subsidiaries in Australia, Brazil, and Chile are exposed to fluctuating commodity prices, labour-market rigidities, regulatory changes, and currency volatility, which may impact profitability. In India, although demand fundamentals remain strong, project execution risks persist due to supply-chain disruptions, input-cost variability, and infrastructure bottlenecks. The industry is also witnessing intensifying competition from international OEMs, low-cost regional players, and integrated automation providers, increasing pricing pressure and shortening product-life cycles. As mining and industrial clients accelerate digital adoption, the Company must continuously invest in new technologies, skilled manpower, and advanced diagnostics to remain competitive. Environmental norms related to emissions, water usage, and workplace safety are tightening in key markets, potentially increasing compliance and operating costs. Collectively, these factors underscore the need for agile cost management, technology upgradation, and disciplined operational execution.

FUTURE OUTLOOK

The future outlook remains cautiously optimistic, supported by favourable economic fundamentals in India, rising global mining activity, and investments in material handling and industrial services. However, growth may be moderated by external and structural risks, including commodity cycles, regulatory developments, project execution delays, geopolitical uncertainties, currency fluctuations, and global macroeconomic pressures.

BOARD'S REPORT

Companies that prioritize innovation, operational resilience, and sustainability will be better positioned to capitalize on emerging opportunities and maintain a competitive edge in an evolving global landscape.

The global industrial market is gradually evolving towards predictive maintenance, remote monitoring, and digital optimisation. While the Company is strengthening capabilities in these areas, adoption rates among customers may be gradual, requiring sustained investment and posing risks related to technology integration and return on investment. Though international subsidiaries in Australia, the Middle East, and Latin America are continuing to build operational strength and market presence, these regions carry exposure to geopolitical uncertainties, currency fluctuations, and differing regulatory environments, which could impact profitability and contract execution.

Over the medium term, Thejo's focus on advanced materials, digital tools, and lifecycle-based service models is expected to enhance competitiveness and expand recurring revenue streams. While the Company maintains a diversified product portfolio and a disciplined cost structure, global macroeconomic uncertainties, supply chain disruptions, and competitive pressures remain key challenges. Accordingly, sustaining profitable growth will require continued focus on operational efficiency, prudent capital allocation, and adaptability to changing market dynamics.

The overall outlook for the future is positive combined with a high degree of uncertainty and unpredictability. Notwithstanding current global disruptions and associated risks, the Company remains optimistic, agile and forward looking in pursuing opportunities that may arise from recovery-driven investments, rebuilding initiatives, and renewed development activity across markets. The Company and the Management are prepared to take swift decisions based on emerging situation, keeping the interest of all stakeholders in mind.

FINANCIAL PERFORMANCE

The financial performance of the Company during the year under review has shown reasonable growth in terms of standalone turnover and profitability. The turnover from Manufacturing Division has increased. The Services Division also witnessed a better performance with increase in turnover. The Company has also stepped up its Information Technology spending focussing on enhanced digitization and digitalization. With focus on digitization, corresponding increase is witnessed in related professional costs and computer maintenance expenses. Increase in other costs are commensurate to the increase in operations and services related activities. Exports registered a growth of about 21% compared to the previous year.

The production of moulded and extruded products was 2,799 tonnes during FY 2025-26, registering a growth of 11% over the previous year (2,533 tonnes). The production of adhesives during the year under review was 484 tonnes, showing a dip of about 14% over the previous year (562 tonnes).

SEGMENT WISE PERFORMANCE

Your Company has 3 segments of revenue – Manufacturing Units, Service Units and Others. Audited financial results of these segments are furnished in Note 26.3, forming part of the Financial Statements.

RISKS AND CONCERNS

The Company has a Risk Management Committee in place, which was constituted by the Board of Directors at their Meeting held on 25th May, 2023. The Company has put in place a Risk Management Policy encompassing the Enterprise Risk Management Framework for identification, assessment, management, monitoring and minimization of risks. It has identified potential risks under various categories like Business Dynamics, Operations, Liquidity, Market/Industry, Human Resources, Systems and Disaster Management. The Company is periodically reviewing the risks and their identification, assessment, monitoring and mitigation procedures. It does not perceive any major technological, operational, financial or environmental risks in the near future except for geopolitical tensions and their impact on the global economy.

BOARD'S REPORT**INTERNAL CONTROL SYSTEM AND THEIR ADEQUACY**

Your Company has adequate internal control systems combined with delegation of powers and periodical review of the process. The control system is also supported by internal audits and management reviews of documented policies and procedures.

DEVELOPMENTS IN HUMAN RESOURCES / INDUSTRIAL RELATIONS

The Company continues to look at, identify, create and execute initiatives that enhance productivity and efficiency. To enthuse the employee base and increase the linear relationship between performance and reward, increments/incentives and stock options are being provided based on performance. Various value creation and enhancement initiatives aligned with the Company's Vision and Mission Statement are being undertaken to drive sustainable growth and long-term organisational values.

The Company will invest as hitherto in people through various initiatives which enable the workforce to meet the production and service expectations and challenges related thereto and to infuse positive enthusiasm towards the organisation, with keen focus on the training and safety of the employees.

SIGNIFICANT CHANGES IN KEY FINANCIAL RATIOS

The profitability of the Company grew marginally to ₹ 5,514.20 lakhs during FY26 as against ₹ 5,000.57 lakhs in the previous year. However, due to good profits and high retained earnings during the previous year, the average equity has increased to ₹ 29,106.66 lakhs during FY26 as against ₹ 24,126.05 lakhs in the previous year. As a result, the Return on equity stood at 18.94% in FY26 compared to 20.73% in FY25. There was no significant change in any other key financial ratios as contained in Schedule V of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations").

As on the date of this Report, the Company has five subsidiaries, namely, Thejo Hatcon Industrial Services Company, Kingdom of Saudi Arabia (Thejo Hatcon) with 51% shareholding, Thejo Engineering LatinoAmerica SpA, Chile (Thejo Chile) with 99.86% shareholding and three Wholly Owned Subsidiaries -Thejo Australia Pty Ltd., Australia (Thejo Australia), Thejo Brasil Comercio E Servicos Ltda, Brazil (Thejo Brasil), and TE Global FZ-LLC, Ras-Al-Khaimah, United Arab Emirates (TE Global).

PERFORMANCE OF SUBSIDIARY COMPANIES

Thejo Hatcon Industrial Services Company (Thejo Hatcon) is engaged primarily in rubber lining and related industrial services activities. During the period, 1st April, 2025 to 31st March, 2026, Thejo Hatcon achieved a turnover of SAR 10.67 million (₹ 2,561.73 lakhs) on which it made a net loss of SAR 0.35 million (₹ 84.14 lakhs).

Thejo Australia Pty Ltd (Thejo Australia) is primarily engaged in belt splicing, belt jointing, maintenance and related activities including sale of associated products and spares. During the period, 1st April, 2025 to 31st March, 2026, Thejo Australia achieved a turnover of AUD 16.73 million (₹ 9,897.48 lakhs) with a net loss of AUD 0.59 million (₹ 346.54 lakhs).

Thejo Brasil Comercio E Servicos Ltda (Thejo Brasil) is mainly engaged in selling materials used in core sector industries for bulk material handling, mineral processing and corrosion protection. During the period, 1st April, 2025 to 31st March, 2026, Thejo Brasil achieved a turnover of BRL 3.98 million (₹ 653.17 lakhs) with a profit of BRL 1.03 million (₹ 169.41 lakhs).

Thejo Engineering LatinoAmerica SpA (Thejo Chile) is primarily engaged in selling materials used in core sector industries for bulk material handling, mineral processing and corrosion protection. During the period, 1st April, 2025 to 31st March, 2026, Thejo Chile achieved a turnover of CLP 2,148.64 million (₹ 2,061.62 lakhs) with a loss of CLP 110.48 million (₹ 106.01 lakhs).

TE Global FZ-LLC (TE Global) is primarily engaged in selling various products used in core sector industries and rendering related services to various customers in the Middle East and other nearby/ related geographies. During the period 1st April, 2025 to 31st March, 2026, TE Global achieved a turnover of AED 1.81 million (₹ 442.73 lakhs) with a net loss of AED 0.35 million (₹ 85.75 lakhs).

CONSERVATION OF ENERGY, RESEARCH AND DEVELOPMENT, TECHNOLOGY ABSORPTION, FOREIGN EXCHANGE EARNINGS AND OUTGO

Consequently, the charge of depreciation for the year ended March 31, 2026 on account of change in the accounting estimate is lower by Rs.737.02 lakhs respectively with a corresponding impact in the Profit Before Tax (PBT) of the company and an impact of Rs.551.51 lakhs respectively in the Profit After Tax (PAT) on account of change in the depreciation method.

Our opinion is not modified with reference to this change in accounting estimate.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the standalone financial statements of the current period. These matters were addressed in the context of our audit of the standalone Ind AS financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. Note 1

Corporate Information

Thejo Engineering Limited ("the Company") is a public limited company, with its Registered Office at VDS House, 3rd Floor, No. 41, Cathedral Road, Chennai 600086. The Company is an Engineering Solutions provider for Bulk Material Handling, Mineral Processing and Corrosion Protection to the Core Sector Industries like mining, power, steel, cement, ports and fertilizers. The Company's services include belt conveyor installation, maintenance and operations, while its product portfolio covers design, manufacture and supply of engineering products for Bulk Material Handling, Mineral Processing and Corrosion Protection.

The Company has five overseas subsidiaries namely, Thejo Hatcon Industrial Services Company, Saudi Arabia, Thejo Australia Pty Ltd, Australia, Thejo Brasil Comercio E Servicos Ltda, Brazil, Thejo Engineering LatinoAmerica SpA, Chile and TE Global FZ-LLC, Ras-Al-Khaimah. Thejo Hatcon Industrial Services Company is primarily engaged in rubber lagging and industrial services, Thejo Australia Pty Ltd in conveyor splicing, maintenance, services and sale of related products, Thejo Brasil Comercio E Servicos Ltda, Thejo Engineering LatinoAmerica SpA in sale of products used in core sector industries for Bulk Material Handling, Mineral Processing and Corrosion Protection and TE Global FZ-LLC in sale of products used in core sector industries for Bulk Material Handling, Mineral Processing and Corrosion Protection and related services. The Company has branches at various locations in India.

The shares of the Company are listed on the National Stock Exchange of India Limited (NSE).

Basis of Preparation and Material Accounting Policies

Note 2

Basis of Preparation

2.1 *Basis of preparation*

These Financial Statements for the year ended 31st March, 2026 have been prepared under Ind-AS on accrual and going concern basis using accounting policies that are applied consistently. The assets and liabilities have been classified as Current or Non-Current based on the normal operating cycle of the Company, which has been determined as 12 months based on the nature of products and services, and the time gap between acquisition of assets for processing and their realisation in cash and cash equivalents.

The financial statements for the year ended 31st March, 2026 were approved for issue by the Board of Directors at their meeting held on 27th May, 2026.

2.2 *Basis of measurement*

The financial statements have been prepared under historical cost convention unless stated otherwise.

2.3 *Use of estimates and judgements*

In the preparation of financial statements, the management has to make certain estimates, judgements and assumptions in the application of accounting policies that affects the reported amounts of assets, liabilities, income and expenses. Actual outcome may differ from these estimates. The management continuously evaluates these estimates and judgements and make appropriate revisions prospectively.

Notes forming part of the Financial Statements for the year ended 31st March, 2026

Information about critical judgements, estimates and assumptions that have the most significant impact on the amounts recognized in the financial statements are included in the following notes:

- (a) Measurement of defined benefit obligations
- (b) Measurement and likelihood of occurrence of provisions and contingencies
- (c) Recognition of deferred tax assets
- (d) Useful lives of property, plant and equipment
- (e) Useful lives of intangible assets
- (f) Measurement of share based payments

2.4 Functional and Presentation Currency

Items included in the financial statements of the Company are recorded using the currency of the primary economic environment in which the Company operates ("the functional currency"). Indian Rupee ("INR"/"Rs."/"₹") is the functional currency of the Company.

The Financial Statements are presented in INR, which is the presentation currency of the Company. Presentation is made in INR rounded to the nearest lakh except where indicated otherwise.

2.5 Recent Accounting Pronouncements

The Ministry of Corporate Affairs (MCA) notifies new standards or amendments to the existing standards under the Companies (Indian Accounting Standard) Rules, 2015, from time to time. For the year ended 31st March, 2026, MCA has notified amendments to Ind-AS 1 – Presentation of Financial Statements (classification of liabilities as current or non-current, including liabilities with covenants), Ind-AS 12 - Income Taxes (International Tax Reform - Pillar Two Model Rules), Ind AS 21 – The effects of changes in Foreign Exchange Rates (Lack of exchangeability) and Ind AS 7 – Statement of Cash Flows and Ind AS 107 – Financial Instruments Disclosures (Supplier Finance arrangements). Based on a review and evaluation of the new pronouncements, the Company has determined that they do not have any significant impact on the financial statements.

Note 3**Material Accounting Policies**

The material accounting policies used in the preparation of the financial statements are set out below. These policies have been consistently applied to all years presented, unless stated otherwise.

3.1 Property, Plant and Equipment

Property, Plant and Equipment (PPE) are stated at acquisition cost less accumulated depreciation and accumulated impairment losses, if any.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Cost includes professional fees and, for qualifying assets, borrowing costs capitalized in accordance with the Company's accounting policy. Such properties are classified to the appropriate categories of PPE when completed and ready for intended use. Depreciation of these assets, on the same basis as other PPE assets, commences when the assets are ready for their intended use. PPE which are not ready for intended use are disclosed under "Capital work-in-progress".

Notes forming part of the Financial Statements for the year ended 31st March, 2026

Subsequent cost/expenses related to an item of PPE are recognized in the carrying amount of PPE when the cost/expenses meet the recognition criteria, i.e. cost can be measured reliably and it is probable that the future benefits will flow to the Company.

Effective 1st April 2025, the Company has adopted Straight Line Method (SLM) of depreciation instead of Written Down Value (WDV) method on Property, Plant and Equipment (PPE), based on the Management assessment of the expected pattern of consumption of the future economic benefits embodied in the PPE, without any change in the remaining useful life of the assets.

Depreciation is charged on a pro-rata basis under straight line method based on the useful life of individual asset as prescribed in Schedule II of the Companies Act, 2013 ("the Act"), retaining a residual value of 5% of the cost of the assets except the following:

Plant and equipment are depreciated over a period of 1 to 15 years, office equipment over 2 to 5 years and Dyes and Moulds over 3 to 10 years based on technical evaluation/advice.

No depreciation is charged on the free hold land.

The residual value, useful lives and depreciation method are reviewed at the end of each reporting period and adjustment required, if any, are done prospectively.

Assets on leased premises, which cannot be used independent of the leased premises, are depreciated on the remaining period of lease or as per the useful life as stated above, whichever is earlier. Assets costing ₹ 5,000 and below are depreciated over a period of one year.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sale proceeds and the carrying amount of the asset and is recognised in the Statement of Profit and Loss.

Upon first time adoption of Ind-AS, the Company had elected to measure all its property, plant and equipment at the carrying value under Previous GAAP as their deemed cost on the date of transition to Ind-AS (1st April, 2020).

3.2 *Intangible Assets*

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortization and accumulated impairment losses.

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- (a) The technical feasibility of completing the intangible asset so that it will be available for use or sale;
- (b) The intention to complete the intangible asset and use or sell it;
- (c) The ability to use or sell the intangible asset;
- (d) The probable future economic benefits that will be generated from the intangible asset;
- (e) The availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- (f) The ability to measure reliably the expenditure attributable to the intangible asset during its development.

Notes forming part of the Financial Statements for the year ended 31st March, 2026

The amount initially recognised for internally-generated intangible assets is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally generated intangible asset can be recognised, development expenditure is recognised in the Statement of Profit and Loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible assets are reported at cost less accumulated amortization and accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

Effective 1st April 2025, the Company has adopted Straight Line Method (SLM) of amortization instead of Written Down Value (WDV) method on intangible assets, based on the Management assessment of the expected pattern of consumption of the future economic benefits embodied in the intangible assets, without any change in the remaining useful life of the assets.

Amortization of intangible assets is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortization method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses.

An intangible asset is derecognized on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in the Statement of Profit and Loss when the asset is derecognized.

Estimated useful lives of the intangible assets are as follows:

Upon first time adoption of Ind-AS, the Company had elected to measure its intangible assets at the carrying value under Previous GAAP as their deemed cost on the date of transition to Ind-AS (1st April, 2020).

Impairment of Tangible & Intangible Assets

At the end of each reporting period, the Company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). When it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash generating units, or otherwise they are allocated to the smallest group of cash generating units for which a reasonable and consistent allocation basis can be identified.

Intangible assets with indefinite useful lives, goodwill and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in the Statement of Profit and Loss.

When an impairment loss subsequently reverses, the carrying amount of the asset (or a cash generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash generating unit) in prior years. A reversal of an impairment loss is recognised immediately in the Statement of Profit and Loss.

3.3 Leases**Company as Lessee**

At the inception of a contract, the Company assesses if the contract conveys the right to control the use of an identified asset for a specified period of time for a consideration. If so, such contracts are considered to be/to contain lease. Where the Company is a lessee, except in case of short-term leases (tenure less than twelve months) and leases of low value assets, the Company recognizes lease liability and right-of-use assets. In the case of leases for short-term and leases of low value assets, the Company recognises the lease payments as an operating expense on a straight-line basis over the term of the lease. The right-of-use assets are initially recognised at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or prior to the commencement date of the lease plus any initial direct costs less any lease incentives. They are subsequently measured at cost less accumulated depreciation and impairment losses, if any. Right-of-use assets are depreciated from the commencement date on a straight-line basis over the shorter of the lease term and useful life of the underlying asset. The lease liability is initially measured at the present value of the future lease payments, discounted using the interest rate implicit in the lease or, if not readily determinable, using the incremental borrowing rates being the rate the Company would have to pay to borrow fund necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions. Subsequent to the initial measurement, the lease liability is increased by the interest on the lease liability and reduced by the lease payments made. A lease liability is re-measured when there is a change in the lease term or a change in an index or rate used to determine lease payments, etc. Lease liability and Right-of-use asset are presented separately in the Balance Sheet. In the Statement of Cash Flows, lease payments have been classified as cash flow from financing activities.

Company as Lessor

Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as expenses over the lease term on the same basis as lease income. The respective leased assets are included in the balance sheet based on their nature.

3.4 Investment in Subsidiaries and Joint Ventures

Investments in subsidiaries and joint ventures are carried at cost net of accumulated impairment losses, if any. Where an indication of impairment exists, the carrying value of the investment is assessed for the amount of impairment loss and written down to its recoverable amount. At the time of disposal of investments, the difference between the net proceeds of disposal and the carrying amount is recognized in the Statement of Profit and Loss.

Upon first time adoption of Ind-AS, the Company had elected to measure its investment in subsidiaries at the carrying value under Previous GAAP as their deemed cost on the date of transition to Ind-AS (1st April, 2020).

3.5 *Inventories*

Inventories are valued at lower of cost and net realisable value based on FIFO Basis. Cost of work-in-progress and finished goods includes the cost of purchase, conversion and all other cost incurred in bringing the inventory to their current condition and location. Net realizable value is the estimated selling price in the ordinary course of business net of estimated cost of completion and cost required to be incurred to complete the sale.

3.6 *Cash and Cash Equivalents*

Cash and cash equivalents are short-term (three months from the date of acquisition), highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of changes in value.

3.7 *Financial Instruments**A. Financial Assets*

Financial assets comprises investments in equity and debt securities, trade receivables, cash and cash equivalents, and other financial assets. Financial assets are recognized when the Company becomes a party to the contractual positions of an instrument.

Trade receivables are recognized initially at transaction cost and other financial assets are recognized initially at fair value. In the case of financial assets other than those recognized at fair value through profit and loss (FVTPL), the transaction costs attributable to the acquisition of financial assets are added to the fair value for the initial recognition. In the case of financial assets recognized at FVTPL, the transaction costs are recognized in the Statement of Profit and Loss.

Financial assets are subsequently measured at

- (i) Amortized cost
- (ii) Fair value through other comprehensive income (FVOCI) or
- (iii) Fair value through profit and loss (FVTPL)

- (i) Amortized Cost

Financial assets that are held within the business model with an objective to hold them to collect the contractual cash flows that are solely payments of principal and interest on the principal outstanding are measured subsequently at amortized cost using the effective interest rate method (EIR method) net of impairment, if any. The amortization as per EIR and loss on account of impairment, if any, are recognized in the Statement of Profit and Loss.

By applying the above criteria, the following financial assets are measured at amortized cost:

- (a) Trade receivables
- (b) Loans
- (c) Other financial assets

Notes forming part of the Financial Statements for the year ended 31st March, 2026**(ii) Fair value through other comprehensive income**

Financial assets that are held within the business model whose objective is achieved by both selling the financial assets and collecting the contractual cash flows that are solely payments of principal and interest are measured subsequently at fair value through other comprehensive income. Movements in the fair value of such financial asset are recognized in the other comprehensive income. Interest income as per EIR and loss on account of impairment, if any, are recognized in the Statement of Profit and Loss. On derecognition, the cumulative gain or loss that has previously been recognized in the other comprehensive income is reclassified to other income in the Statement of Profit and Loss.

(iii) Fair value through profit or loss

A financial asset is measured subsequently at fair value through profit or loss if it does not meet the classification criteria for measurement at amortized cost or fair value through other comprehensive income. Such financial assets are measured at fair value with all changes in the fair value, including interest and dividend income, if any, being recognized as other income in the Statement of Profit and Loss.

A financial asset is derecognized when the contractual rights to the cash flow from the asset expires, or when the contractual rights to receive the cash flows are transferred.

Subsequent to initial recognition, impairment losses are recognized in respect of all financial assets other than those classified for subsequent measurement under FVTPL. In respect of trade receivables, expected credit loss over the lifetime of the asset is estimated by adopting a simplified approach of provision matrix based on historical loss rates reflecting present conditions and forecast of future economic conditions. Under this approach, trade receivables are grouped on the basis of similar credit characteristics such as industry, customer segment, past due status and other relevant factors to estimate the expected cash loss from these assets. In respect of financial assets other than trade receivables, if the credit risk has increased significantly since initial recognition, the impairment is measured at lifetime credit losses. The impairment losses and reversals are recognized in the Statement of Profit and Loss.

Foreign exchange gains and losses

The fair value of financial assets denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the end of each reporting period.

For foreign currency denominated financial assets measured at amortized cost and FVTPL, the exchange differences are recognised in the Statement of Profit and Loss except for those which are designated as hedging instruments in a hedging relationship.

B. Financial Liabilities

Financial liabilities are recognized when the Company becomes a party to the contractual positions of an instrument.

Financial liabilities are recognized initially at fair value. In the case of financial liabilities other than those recognized at fair value through profit and loss (FVTPL), the transaction costs attributable to the acquisition of the financial liability are added to the fair value for the initial recognition. In the case of financial liabilities recognized at FVTPL, the transaction costs are recognized in the Statement of Profit and Loss.

Financial liabilities other than those recognized at FVTPL are subsequently measured at amortized cost using EIR method. Financial liabilities carried at FVTPL are measured at fair value with all changes in fair value recognized in the Statement of Profit and Loss.

The Company measures the following financial liabilities under amortized cost:

- (a) Borrowings
- (b) Lease liabilities
- (c) Trade payables
- (d) Other financial liabilities

Financial liabilities held for trading are measured at FVTPL.

Financial liabilities and financial assets are offset and net amount presented in the Balance Sheet when the Company has a legal right to offset and intends to settle the same on net basis or realize the asset and settle the liability simultaneously.

A financial liability is derecognized when it is extinguished, i.e. when the obligation specified in the contract is discharged, cancelled or expires.

Foreign exchange gains and losses

For financial liabilities that are denominated in a foreign currency and are measured at amortized cost at the end of each reporting period, the foreign exchange gains and losses are determined based on the amortized cost of the instruments and are recognised in Statement of Profit and Loss under other income.

The fair value of financial liabilities denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the end of the reporting period. For financial liabilities that are measured at FVTPL, the foreign exchange component forms part of the fair value gains or losses and is recognised in the Statement of Profit and Loss.

C. Fair Value Hierarchy

The fair value of financial instruments are classifiable into three categories based on the inputs used in valuation technique. The three categories are as follows:

Level 1: Quoted prices for identical instruments in an active market

Level 2: Directly or indirectly observable market inputs, other than Level 1 inputs and

Level 3: Inputs which are not based on observable market data.

3.8 Provisions and Contingent Liabilities

Provisions are recognized if the Company has a reliably estimated present obligation (legal or constructive) as a result of a past event and it is probable that an outflow of resources will be required to settle the obligation. Provisions are measured based on the best estimate of expenditure required to settle the obligation as at the date of Balance Sheet. In cases where the effect of the time value of money is material, provisions are discounted to reflect its present value using current pre-tax rate reflecting the risk specific to the obligation. When discounting is used, the increase in the amount of provision due to the passage of time is recognized as finance cost.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, which is contingent upon the occurrence or non-occurrence of one or more uncertain future events, which are not fully within the control of the Company or when there is a present obligation arising from past events where it is either not probable that an outflow of resources will be required to settle the obligation or the amount cannot be reliably estimated.

A contingent asset is not recognised but disclosed in the financial statements where an inflow of economic benefit is probable. Commitments includes the amount of purchase order (net of advance) issued to counterparties for supplying/ development of assets and amounts pertaining to investments which have been committed but not called for.

Provisions, contingent assets, contingent liabilities and commitments are reviewed at each Balance Sheet date.

3.9 Revenue Recognition**Sale of goods**

Revenue is recognised at transaction value when the performance obligations are satisfied and the control of the product is transferred, being when the goods are delivered as per the relevant terms of the contract at which point in time the Company has a right to payment for the asset, customer has legal title of the asset, customer bears significant risk and rewards of ownership and the customer has accepted the asset or the Company has objective evidence that all criteria for acceptance have been satisfied. Payment for the sale is made as per the credit terms in the agreements with the customers. The credit period is generally short term, thus there is no significant financing component.

Rendering of services

The performance obligations under service contracts are provision of various services as set forth in the contracts. Revenue from rendering of services is recognised over a period of time by reference to the stage of completion as the customer simultaneously receives and consumes the benefit provided by the Company's performance. Payment for the service rendered is made as per the credit terms in the agreements with the customers. The credit period is generally short term, thus there is no significant financing component.

Dividend and interest income

Dividend income from investments is recognised when the shareholder's right to receive payment has been established (provided that it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably).

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Revenue disaggregation as per business segment and geography are contained in the segment information given in Note 26.3.

All short-term employee benefit obligations are measured on an undiscounted basis and expensed as the related services are rendered.

Defined contribution plans

Contribution to defined contribution plans like provident fund, superannuation fund, employee state insurance, etc are charged as an expense to the extent of periodic contribution required to be made as and when services are rendered to the Company. The Company has no further obligations beyond the periodic contribution in respect of defined contribution plans.

Defined benefit plans

The Company provides for gratuity, a defined benefit plan, to all eligible employees. The amount recognized as employee benefit expense in the Statement of Profit and Loss is the cost of accruing employee benefits promised to the eligible employees over the year and costs of past/future service benefit changes and similar costs. The defined benefit plan surplus or deficit as on the date of Balance Sheet comprises the difference between fair value of plan assets and present value of the defined benefit liabilities, discounted at the yield rate at the reporting date on risk free government bonds.

All remeasurements of defined benefit liabilities and assets are recognized in other comprehensive income and are subsequently not reclassified to the Statement of Profit and Loss. The Company has an employees' gratuity fund managed by the Life Insurance Corporation of India.

3.11 Share-based Payments

Equity-settled share-based payments to employees are measured at the fair value of the equity instruments at the grant date. Details regarding the determination of the fair value of equity-settled share-based transactions are set out in Note 26.9.

The Company makes equity settled share-based payment to selected employees under its ESOP program. The fair value of options granted as on grant date, calculated by an independent valuer on the basis of Black Scholes model, is recognized as employee benefit expense with a corresponding increase in equity over the vesting period. At the end of each reporting period, the expense is reviewed and adjusted to reflect changes to the level of options expected to vest. Fresh equity shares are issued upon exercise of vested options.

3.12 Income tax Expenses

Income tax expenses comprise current tax and deferred tax and is recognized in the Statement of Profit and Loss except to the extent that it relates to an item which is recognized directly in equity or in other comprehensive income. Current tax is the expected tax payable on the taxable income using applicable tax rates enacted or substantively enacted as at the reporting date and any adjustments relating to income tax of previous years.

Deferred tax is recognized in respect of temporary difference between the carrying amounts of assets and liabilities as per the financial statements and taxation laws. Deferred tax liability is recognized based on the expected manner of realization or settlement of the difference in carrying amounts applying tax rates enacted or substantively enacted as at the reporting date. Deferred tax assets are recognized only to the extent that it is probable that future taxable profits will be available to utilize the same. Deferred tax assets are reviewed at each reporting date and reduced to the extent that it is no longer probable that it will be realized.

Notes forming part of the Financial Statements for the year ended 31st March, 2026

Current tax assets and liabilities are offset when there is a legally enforceable right to set them off and there is an intent to settle them on a net basis. Deferred tax assets and liabilities are set off when they are related to income tax levied by the same taxation authority and there is a legally enforceable right to set off current tax assets and liabilities.

3.13 Foreign Currency

In preparing the financial statements of the Company, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated. Exchange differences on monetary items are recognised in the Statement of Profit and Loss in the period in which they arise.

3.14 Earnings Per Share

The Company presents the basic earnings per share by dividing the net profit for the period attributable to ordinary shareholders by the weighted average number of ordinary shares outstanding during the period. Where ordinary shares are issued without a corresponding change in resources like bonus issue, the weighted average number of equity shares outstanding during the period as well as all periods presented are adjusted for such events.

Diluted earnings per share is computed by dividing the net profit after tax by the weighted average number of equity shares considered for deriving basic earnings per share and also weighted average number of equity shares that could have been issued upon conversion of all dilutive potential equity shares. Dilutive potential equity shares are deemed converted as of the beginning of the period, unless issued at a later date. Dilutive potential equity shares are determined independently for each period presented. The number of equity shares and potentially dilutive equity shares are adjusted for bonus shares, consolidation of shares, etc. as appropriate.

3.15 Segment Reporting

The Company reports business and geographic segments in a manner consistent with the reporting provided to the Chief Operating Decision Maker, in line with Ind-AS 108.

3.16 Dividend Distributed to Equity Shareholders

Dividend distributed to equity shareholders is recognized as distribution to owners of capital in the Statement of Changes in Equity after it is approved by the Members.

3.17 Borrowings and related costs

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in the Statement of Profit and Loss over the period of the borrowings using the effective interest method. Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are removed from the Balance Sheet when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in the Statement of Profit and Loss as other gains/(losses).

Borrowings are classified as current liabilities unless the Company has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period. Where there is a breach of a material provision of a long-term loan arrangement on or before the end of the reporting period with the effect that the liability becomes payable on demand on the reporting date, the entity does not classify the liability as current, if the lender agreed, after the reporting period and before the approval of the financial statements for issue, not to demand payment as a consequence of the breach.

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization. All other borrowing costs are recognised in the Statement of Profit and Loss in the period in which they are incurred.

3.18 *Cash flow statement*

Cash flows are reported using the indirect method, whereby profit/(loss) before tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The cash flows from operating, investing and financing activities of the Company are segregated based on the available information. Cash and cash equivalents includes balances in current accounts, debit balance in cash credit accounts, cash on hand and cheques/drafts on hand. Bank overdrafts are shown within borrowings in current liabilities in the Balance Sheet.

Other price risks

Company's investments in equity instruments are restricted to its investment in its subsidiaries, which are held for strategic purposes rather than for trading. The Company, as on the reporting date of March 31, 2026 has five subsidiaries. All the five subsidiaries are incorporated abroad, closely held companies and unlisted.

As the purpose of all such investments are strategic rather than for trading, the Company does not recognise any impact of sensitivity in the equity prices.

Credit Risk Management

The credit risk to the Company arises primarily from customers defaulting on their contractual obligations, thus resulting in financial loss to the Company.

As part of mitigation process to address the risk, the Company evaluates the credentials of a customer before participating in the tender or before quoting for their order. The Company evaluates the potential customers' credentials by considering various factors such as:

- (i) their financial health based on the publicly available financial statements;
- (ii) their credit rating, available in the public domain;
- (iii) their repute in the market; and
- (iv) past experience, if the Company has done any business with them earlier.

The Company makes provision on its financial assets, on every reporting period, as per Expected Credit Loss Method. The percentage at which the provision is made, is determined on the basis of historical experience of such provisions, modified to the current and prospective business and customer profile.

Trade receivables consist of large number of customers, spread across diverse industries and geographical areas.

Many of the customers of the Company comprise of Public Sector Undertakings, with whom the Company does not perceive any major risk.

Liquidity Risk Management

The liquidity requirements of the Company are met by equity (including internal accruals) and working capital limits from the banks. The liquidity requirements for the operations are met by allocating the cash flows from the customers.

The Company has established a practice of prioritising the regulatory payments, employee related payments and supplier/ site level payments.

26.19.7 During the FY 2025-26, the Company has incurred a revenue expenditure (excluding depreciation) of ₹ 186.35 lakhs and capital expenditure of ₹ 48.58 lakhs in relation to Research & Development. (FY 2024-25: ₹ 250.44 lakhs and ₹ 18.87 lakhs, respectively).

26.19.8 The Code on Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 ("the New Labour Codes") were notified by the Central Government on 21st November, 2025. The New Labour Codes have consolidated the existing labour laws contained in 29 different statutes into a unified framework under four Codes. The Company has assessed the financial implication on account of the New Labour Codes and the same has resulted in an increase in gratuity and leave encashment expenses to an extent of ₹ 273.11 lakhs attributable to the past service of the employees, primarily due to change in the definition of Wages under the New Labour Codes. The Company has disclosed the same as an exceptional item for the year ended 31st March 2026 as this is a one-time charge in respect of the past service cost. It has been included as part of unallocable expenses in the segment results.

26.19.9 Effective 1st April 2025, the Company has adopted Straight Line Method (SLM) of depreciation instead of Written Down Value (WDV) method on Property, Plant and Equipment (PPE) and intangible assets, based on the Management assessment of the expected pattern of consumption of the future economic benefits embodied in the PPE and intangible assets, without any change in the remaining useful life of the assets. Consequently, the charge of depreciation for the year ended 31st March, 2026 is lower by ₹ 737.02 lakhs with a corresponding impact in the Profit Before Tax (PBT) and an impact of ₹ 551.51 lakhs in the Profit After Tax (PAT) on account of change in the depreciation method.

26.19.10 The Board has recommended a dividend of Rs. 5/- (Rupees Five Only) per equity share of face value of ₹ 10/- each (fully paid) for the FY 2025-26. Dividend will be treated as an appropriation from Reserves & Surplus during the period in which it is approved by the Members. No provision is being made in the accounts for the current financial year in respect of dividend recommended by the Board after the balance sheet date.

Report on the Audit of the Consolidated Ind AS Financial Statements

Opinion

We have audited the accompanying Consolidated Ind AS Financial Statements of Thejo Engineering Limited ("the Holding Company") and its subsidiaries (together referred as "Group") which comprise the Consolidated Balance Sheet as at March 31, 2026, and the Consolidated Statement of Profit and Loss (including other comprehensive income), Consolidated Statement of Changes in Equity and Consolidated Cash Flow Statement for the year then ended, and notes to the consolidated Ind AS financial statements including a summary of significant accounting policies and other explanatory information (hereinafter referred to as "Consolidated Ind AS financial statements").

In our opinion and to the best of our information and according to the explanations given to us and based on the consideration of reports of other auditors on the financial statements of the Subsidiaries the aforesaid Consolidated Ind AS financial statements give the information required by the Companies Act, 2013 in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the consolidated state of affairs of the Group as at March 31, 2026, of consolidated profit and other comprehensive Income, consolidated changes in equity and its consolidated cash flows for the year then ended.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies act, 2013. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Ind AS financial statements section of our report. We are independent of the Group in accordance with the Code of Ethics issued by Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the consolidated Ind AS financial statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion on the Consolidated Ind AS Financial Statements.

Emphasis of matter

Effective April 01, 2025, the Company has adopted Straight Line Method (SLM) of depreciation from Written Down Value (WDV) method on Property, Plant and Equipment (PPE) and Intangible Assets, based on the Management assessment of expected pattern of consumption of the future economic benefits arising from PPE and Intangible Assets, without any change in the remaining useful life of the assets.

Consequently, the charge of depreciation for the year ended March 31, 2026 on account of change in the accounting estimate is lower by Rs.737.02 lakhs with a corresponding impact in the Profit Before Tax (PBT) of the company and an impact of Rs.551.51 lakhs in the Profit After Tax (PAT) on account of change in the depreciation method.

Our opinion is not modified with reference to this change in accounting estimate.

INDEPENDENT AUDITOR'S REPORT**Key Audit Matters**

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated Ind AS financial statements of the current period. These matters were addressed in the context of our audit of the consolidated Ind AS financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined that there are no key audit matters to be communicated in our report.

Information Other than the Financial Statements and Auditor's Report Thereon

The Company's Board of Directors are responsible for the preparation of the other information. The other information comprises the information included in the Holding Company's Annual Report, but does not include the Consolidated Ind AS financial statements and our auditor's report thereon.

Our opinion on the Consolidated Ind AS Financial Statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the Consolidated Ind AS Financial Statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Consolidated Ind AS Financial Statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

These financial statements of the subsidiaries have been audited by other auditors whose reports have been furnished to us by the Management and our opinion on the consolidated Ind AS financial statements, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries and our report in terms of subsection (3) of Section 143 of the Act, in so far as it relates to the aforesaid subsidiaries is based solely on the reports of the other auditors.

Our opinion on the Consolidated Ind AS financial statements, and our report on other legal and regulatory legal requirements, is not modified in respect of the above matters with respect to our reliance on the work done and the reports of the other auditors.

Report on Other Legal and Regulatory Requirements

- g) With respect to the other matters to be included in the Auditor's Report in accordance with the requirements of section 197(16) of the Act, as amended:

 - (ii) The Group did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses.

 - (b) The Management of the holding company has represented, that, to the best of its knowledge and belief, no funds (which are material either individually or in the aggregate) have been received by the Company or subsidiary from any person or entity, including foreign entity (“Funding Parties”), with the understanding, whether recorded in writing or otherwise, that the Company or subsidiary shall, whether, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding

Party ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries;

- (c) Based on the audit procedures that we have considered reasonable and appropriate in the circumstances performed by us, nothing has come to our notice that has caused us to believe that the representations as provided under (a) and (b) above, contain any material misstatement.
- (v) The final dividend declared and paid by the Holding Company during the year in respect of the previous financial year is in accordance with section 123 of the Act 2013 to the extent it applies to payment of dividend.

The Board of Directors of the Holding Company have proposed final dividend for the year which is subject to the approval of the members at the ensuing Annual General Meeting. The dividend declared is in accordance with section 123 of the Act to the extent it applies to declaration of dividend.

- (vi) Based on our examination which included test checks and further confirmations from Software provider, the Holding company has used an accounting software for maintaining its books of account for the financial year ended March 31, 2026 which has a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the software. Further, during the course of our audit, we did not come across any instance of audit trail feature being tampered with. Additionally, the audit trail has been preserved by the Company as per the statutory requirements for record retention.

The report on the feature of recording Audit Trail (edit Log) facility in accounting software is not applicable to five subsidiaries as they are incorporated outside India.

- 2. As required by the Companies (Auditor's Report) Order, 2020 ("the Order"), issued by the Central Government of India in terms of sub-section (11) of section 143 of the Companies Act, 2013, according to the information and explanations given to us, and based on the CARO reports issued by us for the holding Company, we report that there are no qualifications or adverse remarks in the CARO report of Holding Company. Note 1

Group Information

Thejo Engineering Limited ("the Company"/"the Parent Company") is a public limited company, with its Registered Office at VDS House, 3rd Floor, No. 41, Cathedral Road, Chennai 600086. The Company is an Engineering Solutions provider for Bulk Material Handling, Mineral Processing and Corrosion Protection to the Core Sector Industries like mining, power, steel, cement, ports and fertilizers. The Company's services include belt conveyor installation, maintenance and operations, while its product portfolio covers design, manufacture and supply of engineering products for Bulk Material Handling, Mineral Processing and Corrosion Protection. The shares of the Company are listed on the National Stock Exchange of India Limited (NSE). The Company has branches at various locations in India.

The Company and its subsidiaries (hereinafter referred to as "the Group") are considered in these consolidated financial statements. The Company has five overseas subsidiaries namely, Thejo Hatcon Industrial Services Company, Saudi Arabia, Thejo Australia Pty Ltd, Australia, Thejo Brasil Comercio E Servicos Ltda, Brazil, Thejo Engineering LatinoAmerica SpA, Chile and TE Global FZ-LLC, Ras-Al-Khaimah. Thejo Hatcon Industrial Services Company is primarily engaged in rubber lagging and industrial services, Thejo Australia Pty Ltd in conveyor splicing, maintenance, services and sale of related products, Thejo Brasil Comercio E Servicos Ltda, Thejo Engineering LatinoAmerica SpA in sale of products used in core sector industries for Bulk Material Handling, Mineral Processing and Corrosion Protection and TE Global FZ-LLC in sale of products used in core sector industries for Bulk Material Handling, Mineral Processing and Corrosion Protection and related services.

Basis of Preparation and Material Accounting Policies

Note 2

Basis of Preparation

2.1 *Basis of preparation*

The Consolidated Financial Statements for the year ended 31st March 2026 have been prepared under Ind-AS on accrual and going concern basis using accounting policies that are applied consistently. The assets and liabilities have been classified as Current or Non-Current based on the normal operating cycle of the Group, which has been determined as 12 months based on the nature of products and services, and the time gap between acquisition of assets for processing and their realisation in cash and cash equivalents.

These Consolidated Financial Statements are prepared in accordance with the principles and procedures required for the preparation and presentation of Consolidated Financial Statements as laid down under Ind-AS 110. The financial statements of the Parent Company and its subsidiaries are consolidated on a line by line basis by adding together the book values of like items of assets, liabilities, incomes and expenses after eliminating intra-group balances, intra-group transactions and unrealised profits resulting therefrom and are presented to the extent possible, in the same manner as the Company's independent financial statements. The financial statements of the Parent Company and its subsidiaries have been consolidated using uniform accounting policies, which have been applied consistently, for like transactions and other events in similar circumstances.

The excess of cost to the Parent Company of its investment in each of the subsidiaries over its share of equity in the respective subsidiary, on the acquisition date, is recognised in the consolidated financial statements as 'goodwill on consolidation' and carried in the consolidated balance sheet as an asset. Where the share of equity in the subsidiary companies as on the date of investment, is in excess of cost of investment of the company, it is recognised as 'capital reserve' and shown under the head Reserves and Surplus, in the consolidated financial statements.

Non-controlling interest in the net assets of the consolidated subsidiaries consists of the amount of equity attributable to the non-controlling shareholders at the dates on which investments are made by the Company in the subsidiary companies and further movements in their share in the equity, subsequent to the dates of investments. These are presented in the Consolidated Balance Sheet separately within equity. The profit and other comprehensive income attributable to non-controlling interest are shown separately in the Consolidated Statement of Profit and Loss and Consolidated Statement of Changes in Equity.

The transactions between the Parent Company and the Subsidiaries are eliminated. Any unrealized profit on the closing inventory and fixed assets held by any Company in the Group out of the sales made by another Company in the Group is reduced from the closing inventory and fixed assets on consolidation.

The Consolidated Financial Statements for the year ended 31st March, 2026 were approved for issue by the Board of Directors at their meeting held on 27th May, 2026.

2.2 *Basis of measurement*

The Consolidated Financial Statements have been prepared under historical cost convention unless stated otherwise.

2.3 *Use of estimates and judgements*

In the preparation of the Consolidated Financial Statements, the management has to make certain estimates, judgements and assumptions in the application of accounting policies that affect the reported amounts of assets, liabilities, income and expenses. Actual outcome may differ from these estimates. The management continuously evaluates these estimates and judgements and make appropriate revisions prospectively.

Information about critical judgements, estimates and assumptions that have the most significant impact on the amounts recognized in the Consolidated Financial Statements are included in the following notes:

- (a) Measurement of defined benefit obligations
- (b) Measurement and likelihood of occurrence of provisions and contingencies
- (c) Recognition of deferred tax assets
- (d) Useful lives of property, plant and equipment
- (e) Useful lives of intangible assets
- (f) Measurement of share based payments

2.4 *Presentation Currency*

The Consolidated Financial Statements are presented in Indian Rupee ("INR"/"Rs."/"₹"), which is the presentation currency of the Parent Company. Presentation is made in INR rounded to the nearest lakh except where indicated otherwise.

2.5 *Recent Accounting Pronouncements*

The Ministry of Corporate Affairs (MCA) notifies new standards or amendments to the existing standards under the Companies (Indian Accounting Standard) Rules, 2015, from time to time. For the year ended 31st March, 2026, MCA has notified amendments to Ind-AS 1 – Presentation of Financial Statements (classification of liabilities as current or non-current, including liabilities

Based on a review and evaluation of the new pronouncements, the Company has determined that they do not have any significant impact on the financial statements.

Note 3

Material Accounting Policies

The material accounting policies used in the preparation of the Consolidated Financial Statements are set out below. These policies have been consistently applied to all years presented, unless stated otherwise.

3.1 *Property, Plant and Equipment*

Property, Plant and Equipment (PPE) are stated at acquisition cost less accumulated depreciation and accumulated impairment losses, if any.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Cost includes professional fees and, for qualifying assets, borrowing costs capitalized in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of PPE when completed and ready for intended use. Depreciation of these assets, on the same basis as other PPE assets, commences when the assets are ready for their intended use. PPE which are not ready for intended use are disclosed under "Capital work-in-progress".

Subsequent cost/expenses related to an item of PPE are recognized in the carrying amount of PPE when the cost/expenses meet the recognition criteria, i.e. cost can be measured reliably and it is probable that the future benefits will flow to the Company.

Effective 1st April 2025, the Parent Company has adopted Straight Line Method (SLM) of depreciation instead of Written Down Value (WDV) method on Property, Plant and Equipment (PPE), based on the Management assessment of the expected pattern of consumption of the future economic benefits embodied in the PPE, without any change in the remaining useful life of the assets.

Depreciation is charged on a pro-rata basis under straight line method based on the useful life of individual asset as prescribed in Schedule II of the Companies Act, 2013 ("the Act"), retaining a residual value of 5% of the cost of the assets except the following:

Plant and equipment are depreciated over a period of 1 to 15 years, office equipment over 2 to 5 years and Dyes and Moulds over 3 to 10 years based on technical evaluation/advice.

No depreciation is charged on the free hold land.

Assets on leased premises, which cannot be used independent of the leased premises, are depreciated on the remaining period of lease or as per the useful life as stated above, whichever is earlier. Assets costing ₹ 5,000 and below are depreciated over a period of one year.

In respect of the subsidiaries, depreciation has been provided on written down value or straight line method at the rates or on the basis of useful life of assets as evaluated and estimated by the Management.

The residual value, useful lives and depreciation method are reviewed at the end of each reporting period and adjustment required, if any, are done prospectively.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sale proceeds and the carrying amount of the asset and is recognised in statement of consolidated profit and loss.

Upon first time adoption of Ind-AS, the Parent Company has elected to measure all its property, plant and equipment at the carrying value under Previous GAAP as their deemed cost on the date of transition to Ind-AS (1st April, 2020). The subsidiaries have measured the same in line with relevant IFRS.

3.2 Intangible Assets

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortization and accumulated impairment losses.

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- (a) The technical feasibility of completing the intangible asset so that it will be available for use or sale;
- (b) The intention to complete the intangible asset and use or sell it;
- (c) The ability to use or sell the intangible asset;
- (d) The probable future economic benefits that will be generated from the intangible asset;
- (e) The availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- (f) The ability to measure reliably the expenditure attributable to the intangible asset during its development.

The amount initially recognised for internally-generated intangible assets is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally generated intangible asset can be recognised, development expenditure is recognised in the Statement of Profit and Loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible assets are reported at cost less accumulated amortization and accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

Effective 1st April 2025, the Parent Company has adopted Straight Line Method (SLM) of amortization instead of Written Down Value (WDV) method on intangible assets, based on the Management assessment of the expected pattern of consumption of the future economic benefits embodied in the intangible assets, without any change in the remaining useful life of the assets.

Amortization of intangible assets is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortization method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses.

An intangible asset is derecognized on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in the Statement of Profit and Loss when the asset is derecognized.

Upon first time adoption of Ind-AS, the Parent Company has elected to measure its intangible assets at the carrying value under Previous GAAP as their deemed cost on the date of transition to Ind-AS (1st April, 2020). The subsidiaries have measured the same in line with relevant IFRS.

Impairment of Tangible & Intangible Assets

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash generating units, or otherwise they are allocated to the smallest group of cash generating units for which a reasonable and consistent allocation basis can be identified.

Intangible assets with indefinite useful lives, goodwill and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in the Consolidated Statement of Profit and Loss.

When an impairment loss subsequently reverses, the carrying amount of the asset (or a cash generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash generating unit) in prior years. A reversal of an impairment loss is recognised immediately in the Consolidated Statement of Profit and Loss.

At the inception of a contract, the Group assesses if the contract conveys the right to control the use of an identified asset for a specified period of time for a consideration. If so, such contracts are considered to be/to contain lease. Where the Group is a lessee, except in case of short-term leases (tenure less than twelve months) and leases of low value assets, the Group recognizes lease liability and right-of-use assets. In the case of leases for short-term and leases of low value assets, the Group recognises the lease payments as an operating expense on a straight-line basis over the term of the lease. The right-of-use assets are initially recognised at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or prior to the commencement date of the lease plus any initial direct costs less any lease incentives. They are subsequently measured at cost less accumulated depreciation and impairment losses, if any. Right-of-use assets are depreciated from the commencement date on a straight-line basis over the shorter of the lease term and useful life of the underlying asset. The lease liability is initially measured at the present value of the future lease payments, discounted using the interest rate implicit in the lease or, if not readily determinable, using the incremental borrowing rates being the rate the Parent Company/subsidiary would have to pay to borrow fund necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions. Subsequent to the initial measurement, the lease liability is increased by the interest on the lease liability and reduced by the lease payments made. A lease liability is re-measured when there is a change in the lease term or a change in an index or rate used to determine lease payments, etc. Lease liability and Right-of-use asset are presented separately in the Consolidated Balance Sheet. In the Consolidated Statement of Cash Flows, lease payments have been classified as cash flow from financing activities.

Group as Lessor

Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as expenses over the lease term on the same basis as lease income. The respective leased assets are included in the Consolidated Balance Sheet based on their nature.

3.4 Inventories

Inventories are valued at lower of cost and net realisable value based on FIFO Basis. Cost of work-in-progress and finished goods includes the cost of purchase, conversion and all other cost incurred in bringing the inventory to their current condition and location. Net realizable value is the estimated selling price in the ordinary course of business net of estimated cost of completion and cost required to be incurred to complete the sale.

3.5 Cash and Cash Equivalents

Cash and cash equivalents are short-term (three months from the date of acquisition), highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of changes in value.

3.6 Financial Instruments

A. Financial Assets

Financial assets comprises investments in equity and debt securities, trade receivables, cash and cash equivalents, and other financial assets. Financial assets are recognized when the Group becomes a party to the contractual positions of an instrument.

Trade receivables are recognized initially at transaction value and other financial assets are recognized initially at fair value. In the case of financial assets other than those recognized at fair value through profit and loss (FVTPL), the transaction costs attributable to the acquisition of financial assets are added to the fair value for the initial recognition. In the case of financial assets recognized at FVTPL, the transaction costs are recognized in the Consolidated Statement of Profit and Loss.

Financial assets are subsequently measured at

- (i) Amortized cost
- (ii) Fair value through other comprehensive income (FVOCI) or
- (iii) Fair value through profit and loss (FVTPL)

(i) Amortized Cost

Financial assets that are held within the business model with an objective to hold them to collect the contractual cash flows that are solely payments of principal and interest are measured subsequently at amortized cost using the effective interest rate method (EIR method) net of impairment, if any. The amortization as per EIR and loss on account of impairment, if any, are recognized in the Consolidated Statement of Profit and Loss.

By applying the above criteria, the following financial assets are measured at amortized cost:

- (a) Trade receivables
- (b) Loans
- (c) Other financial assets

(ii) Fair value through other comprehensive income

Financial assets that are held within the business model whose objective is achieved by both selling the financial assets and collecting the contractual cash flows that are solely payments of principal and interest are measured subsequently at fair value through other comprehensive income. Movements in the fair value of such financial asset are recognized in the other comprehensive income. Interest income as per EIR and loss on account of impairment, if any, are recognized in the Consolidated Statement of Profit and Loss. On derecognition, the cumulative gain or loss that has previously been recognized in the other comprehensive income is reclassified to other income in the Consolidated Statement of Profit and Loss.

(iii) Fair value through profit or loss

A financial asset is measured subsequently at fair value through profit or loss if it does not meet the classification criteria for measurement at amortized cost or fair value through other comprehensive income. Such financial assets are measured at fair value with all changes in the fair value, including interest and dividend income, if any, being recognized as other income in the Consolidated Statement of Profit and Loss.

A financial asset is derecognized when the contractual rights to the cash flow from the asset expires, or when the contractual rights to receive the cash flows are transferred.

Subsequent to initial recognition, impairment losses are recognized in respect of all financial assets other than those classified for subsequent measurement under FVTPL. In respect of trade receivables, expected credit loss over the lifetime of the asset is estimated by adopting a simplified approach of provision matrix based on historical loss rates reflecting present conditions and forecast of future economic conditions. Under this approach, trade receivables are grouped on the basis of similar credit characteristics such as industry, customer segment, past due status and other relevant factors to estimate the expected cash loss from these assets. In respect of financial assets other than trade receivables, if the credit risk has increased significantly since initial recognition, the impairment is measured at lifetime credit losses. The impairment losses and reversals are recognized in the Consolidated Statement of Profit and Loss.

Foreign exchange gains and losses

The fair value of financial assets denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the end of each reporting period.

For foreign currency denominated financial assets measured at amortized cost and FVTPL, the exchange differences are recognised in the Consolidated Statement of Profit and Loss except for those which are designated as hedging instruments in a hedging relationship.

B. Financial Liabilities

Financial liabilities are recognized when the Group becomes a party to the contractual positions of an instrument.

Financial liabilities are recognized initially at fair value. In the case of financial liabilities other than those recognized at fair value through profit and loss (FVTPL), the transaction costs attributable to the acquisition of the financial liability are added to the fair value for the initial recognition. In the case of financial liabilities recognized at FVTPL, the transaction costs are recognized in the Consolidated Statement of Profit and Loss.

Financial liabilities other than those recognized at FVTPL are subsequently measured at amortized cost using EIR method. Financial liabilities carried at FVTPL are measured at fair value with all changes in fair value recognized in the Consolidated Statement of Profit and Loss.

The Group measures the following financial liabilities under amortized cost:

- (i) Borrowings
- (ii) Lease liabilities
- (iii) Trade payables
- (iv) Other financial liabilities

Financial liabilities held for trading are measured at FVTPL.

Financial liabilities and financial assets are offset and net amount presented in the Consolidated Balance Sheet when the Group has a legal right to offset and intends to settle the same on net basis or realize the asset and settle the liability simultaneously.

A financial liability is derecognized when it is extinguished, i.e. when the obligation specified in the contract is discharged, cancelled or expires.

For financial liabilities that are denominated in a foreign currency and are measured at amortized cost at the end of each reporting period, the foreign exchange gains and losses are determined based on the amortized cost of the instruments and are recognised in the Consolidated Statement of Profit and Loss.

The fair value of financial liabilities denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the end of the reporting period. For financial liabilities that are measured at FVTPL, the foreign exchange component forms part of the fair value gains or losses and is recognised in the Consolidated Statement of Profit and Loss.

C. Fair Value Hierarchy

The fair value of financial instruments are classifiable into three categories based on the inputs used in valuation technique. The three categories are as follows:

Level 1: Quoted prices for identical instruments in an active market

Level 2: Directly or indirectly observable market inputs, other than Level 1 inputs and

Level 3: Inputs which are not based on observable market data.

3.7 Provisions and Contingent Liabilities

Provisions are recognized if the Group has a reliably estimated present obligation (legal or constructive) as a result of a past event and it is probable that an outflow of resources will be required to settle the obligation. Provisions are measured based on the best estimate of expenditure required to settle the obligation as at the date of Consolidated Balance Sheet. In cases where the effect of the time value of money is material, provisions are discounted to reflect its present value using current pre-tax rate reflecting the risk specific to the obligation. When discounting is used, the increase in the amount of provision due to the passage of time is recognized as finance cost.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, which is contingent upon the occurrence or non-occurrence of one or more uncertain future events, which are not fully within the control of the Group or when there is a present obligation arising from past events where it is either not probable that an outflow of resources will be required to settle the obligation or the amount cannot be reliably estimated.

A contingent asset is not recognised but disclosed in the financial statements where an inflow of economic benefit is probable. Commitments includes the amount of purchase order (net of advance) issued to counterparties for supplying/ development of assets and amounts pertaining to Investments which have been committed but not called for.

Provisions, contingent assets, contingent liabilities and commitments are reviewed at each Consolidated Balance Sheet date.

3.8 Revenue Recognition

Sale of goods

Revenue is recognised at transaction value when the performance obligations are satisfied and the control of the product is transferred, being when the goods are delivered as per the relevant terms of the contract at which point in time the Group has a right to payment for the asset, customer has legal title of the asset, customer bears significant risk and rewards of ownership and the customer has accepted the asset or the Group has objective evidence that all criteria for acceptance have been satisfied. Payment for the sale is made as per the credit terms in the agreements with the customers. The credit period is generally short term, thus there is no significant financing component.

Rendering of services

The performance obligation under service contracts are provision of various services as set forth in the contracts. Revenue from rendering of services are recognised over a period of time by reference to the stage of completion as the customer simultaneously receives and consumes the benefit provided by the Group's performance. Payment for the service rendered is made as per the credit terms in the agreements with the customers. The credit period is generally short term, thus there is no significant financing component.

Dividend and interest income

Dividend income from investments is recognised when the shareholder's right to receive payment has been established (provided that it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably).

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Revenue disaggregation as per business segment and geography are contained in the segment information given in Note 28.3.

3.9 Employee Benefits

Short-term benefits

All short-term employee benefit obligations are measured on an undiscounted basis and expensed as the related services are rendered.

Contribution to defined contribution plans like provident fund, superannuation fund, employee state insurance, etc are charged as an expense to the extent of periodic contribution required to be made as and when services are rendered to the Company. The Company has no further obligations beyond the periodic contribution in respect of defined contribution plans.

Defined benefit plans

The Company provides for gratuity, a defined benefit plan, to all eligible employees. The amount recognized as employee benefit expense in the Consolidated Statement of Profit and Loss is the cost of accruing employee benefits promised to the eligible employees over the year and costs of past/future service benefit changes and similar costs. The defined benefit plan surplus or deficit as on the date of balance sheet comprises the difference between fair value of plan assets and present value of the defined benefit liabilities, discounted at the yield rate at the reporting date on risk free government bonds.

All re-measurements of defined benefit liabilities and assets are recognized in other comprehensive income and are subsequently not reclassified to the Consolidated Statement of Profit and Loss. The Company has an employees' gratuity fund managed by the Life Insurance Corporation of India.

Employee benefits in respect of subsidiaries are provided as per the applicable laws of the country where the subsidiaries are situated.

3.10 *Share-based Payments*

Equity-settled share-based payments to employees are measured at the fair value of the equity instruments at the grant date. Details regarding the determination of the fair value of equity-settled share-based transactions are set out in Note 28.9.

The Group makes equity settled share based payment to selected employees under its ESOP program. The fair value of options granted as on grant date, calculated by an independent valuer on the basis of Black Scholes model, is recognized as employee benefit expense with a corresponding increase in equity over the vesting period. At the end of each reporting period, the expense is reviewed and adjusted to reflect changes to the level of options expected to vest. Fresh equity shares are issued upon exercise of vested options.

3.11 *Income tax Expenses*

Income tax expenses comprises current tax and deferred tax and is recognized in the Consolidated Statement of Profit and Loss except to the extent that it relates to an item which is recognized directly in equity or in other comprehensive income. Current tax is the expected tax payable on the taxable income using applicable tax rates enacted or substantively enacted as at the reporting date and any adjustments relating to income tax of previous years.

Deferred tax is recognized in respect of temporary difference between the carrying amounts of assets and liabilities as per the financial statements and taxation laws. Deferred tax liability is recognized based on the expected manner of realization or settlement of the difference in carrying amounts applying tax rates enacted or substantively enacted as at the reporting date. Deferred tax assets are recognized only to the extent that it is probable that future taxable profits will be available to utilize the same. Deferred tax assets are reviewed at each reporting date and reduced to the extent that it is no longer probable that it will be realized.

Current tax assets and liabilities are offset when there is a legally enforceable right to set them off and there is an intent to settle them on a net basis. Deferred tax assets and liabilities are set off when they are related to income tax levied by the same taxation authority and there is a legally enforceable right to set off current tax assets and liabilities.

3.12 *Foreign Currency*

In preparing the consolidated financial statements of the Group, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated. Exchange differences on monetary items are recognised in the Consolidated Statement of Profit and Loss in the period in which they arise.

The financial statement of the subsidiaries are translated as follows:

- (i) Share capital: At the original rate when the capital was infused.
- (ii) Fixed assets: Exchange rate prevailing at the end of the year.
- (iii) Current/Non-current assets and Current/Non-current liabilities: Exchange rate prevailing at the end of the year.
- (iv) Revenues and expenses: At the average rate during the year.

The resultant exchange difference is accounted as foreign currency translation reserve, which is routed through Other Comprehensive Income and are accumulated under Foreign Currency Translation Reserve till disposal of the investment.

3.13 *Earnings Per Share*

The basic earnings per share is presented by dividing the net profit for the period attributable to ordinary shareholders by the weighted average number of ordinary shares outstanding during the period. Where ordinary shares are issued without a corresponding change in resources like bonus issue, the weighted number of equity shares outstanding during the period as well as all periods presented are adjusted for such events.

Diluted earnings per share is computed by dividing the net profit after tax by the weighted average number of equity shares considered for deriving basic earnings per share and also weighted average number of equity shares that could have been issued upon conversion of all dilutive potential equity shares. Dilutive potential equity shares are deemed converted as of the beginning of the period, unless issued at a later date. Dilutive potential equity shares are determined independently for each period presented. The number of equity shares and potentially dilutive equity shares are adjusted for bonus shares, consolidation of shares, etc. as appropriate.

3.14 *Segment Reporting*

The Group reports business and geographic segments in a manner consistent with the reporting provided to the Chief Operating Decision Maker, in line with Ind-AS 108.

3.15 *Dividend Distributed to Equity Shareholders*

Dividend distributed to equity shareholders is recognized as distribution to owners of capital in the statement of changes in equity after it is approved by the Members.

3.16 *Borrowings and related costs*

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction

costs) and the redemption amount is recognised in the Consolidated Statement of Profit and Loss over the period of the borrowings using the effective interest method. Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are removed from the Consolidated Balance Sheet when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in the Consolidated Statement of Profit and Loss as other gains/(losses).

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period. Where there is a breach of a material provision of a long-term loan arrangement on or before the end of the reporting period with the effect that the liability becomes payable on demand on the reporting date, the entity does not classify the liability as current, if the lender agreed, after the reporting period and before the approval of the consolidated financial statements for issue, not to demand payment as a consequence of the breach.

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization. All other borrowing costs are recognised in the Consolidated Statement of Profit and Loss in the period in which they are incurred.

3.17 Government Grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received. Government grants are recognised in the Consolidated Statement of Profit and Loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in the Consolidated Statement of Profit and Loss in the period in which they become receivable. Government grant is recognised either as other operating income, or other income or adjusted against expenses depending upon the nature of the grant and the same is followed consistently. The benefit of a government loan at a below-market rate of interest is treated as a government grant, measured as the difference between proceeds received and the fair value of the loan based on prevailing market interest rates.

3.18 Consolidated Cash flow statement

Cash flows are reported using the indirect method, whereby the consolidated profit/(loss) before tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The consolidated cash flows from operating, investing and financing activities of the Group are segregated based on the available information. Cash and cash equivalents includes balances in current accounts, debit balance in cash credit, cash on hand and cheques/drafts on hand. Bank overdrafts are shown within borrowings in current liabilities in the Consolidated Balance Sheet.

The Group's exposure to interest rate risk is limited to the extent of Working capital and Term Loan funding availed from the Bankers, which is at the External Benchmark Lending rate subject to a periodic reset.

Interest rate sensitivity analysis

The interest rate sensitivity analysis is being done based on the assumption that the amount of liability outstanding at the end of the period was outstanding for the whole year and all other variables remaining constant:

If interest rates had been 50 basis points higher: The finance cost, for the FY2025-26, would have been higher and profits would have been lesser by ₹ 2.65 lakhs (FY 2024-25: ₹ 1.67 lakhs).

If interest rates had been 50 basis points lower: The finance cost, for the FY2025-26, would have been lower and profits would have been higher by ₹ 2.65 lakhs (FY 2024-25: ₹ 1.67 lakhs).

This is mainly attributable to Group's exposure to interest rates on its variable rate borrowings.

Other price risks

The Group's investments in equity instruments are restricted to its investment by the Parent Company in subsidiaries, which are held for strategic purposes rather than for trading. As the purpose of all such investments are strategic rather than for trading, the Parent Company does not recognise any impact of sensitivity in the equity prices.

Credit Risk Management

The credit risk to the Group arises primarily from customers defaulting on their contractual obligations, thus resulting in financial loss to the Group

As part of mitigation process to address the risk, the Group evaluates the credentials of a customer before participating in the tender or before quoting for their order. The Group evaluates the potential customers' credentials by considering various factors such as:

- their financial health based on their publicly available financial statements;
- their credit rating, available in the public domain;
- their repute in the market; and
- past experience, if the Group has done any business with them earlier.

The Group makes provision on its financial assets, on every reporting period, as per Expected Credit Loss Method. The percentage at which the provision is made, is determined on the basis of historical experience of such provisions, modified to the current and prospective business and customer profile.

Liquidity Risk Management

The liquidity requirements of the Group are met by Equity (including Internal accruals) and working capital funding from the banks. The liquidity requirements for the operations are met by allocating the cash flows from the customers.

28.18.5 The Parent Company has duly filed necessary quarterly returns to the banks which have extended credit facilities on the basis of security of current assets of the Company and such quarterly statements are in agreement with the books of account. The Company has used its borrowed funds only for the purposes for which they were borrowed. None of the company in the Group has been declared as a willful defaulter by any bank or financial institution or other lender.

28.18.6 The Code on Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 ("the New Labour Codes") were notified by the Central Government on 21st November, 2025. The New Labour Codes have consolidated the existing labour laws contained in 29 different statutes into a unified framework under four Codes. The Parent Company has assessed the financial implication on account of the New Labour Codes and the same has resulted in an increase in gratuity and leave encashment expenses to an extent of ₹ 273.11 lakhs attributable to the past service of the employees, primarily due to change in the definition of Wages under the New Labour Codes. The Company has disclosed the same as an exceptional item for the year ended 31st March 2026 as this is a one-time charge in respect of the past service cost. It has been included as part of unallocable expenses in the segment results. As all the subsidiaries of the Company are located outside India, there is no impact on account of the New Labour Codes in respect of the subsidiaries.

28.18.7 Effective 1st April 2025, the Parent Company has adopted Straight Line Method (SLM) of depreciation instead of Written Down Value (WDV) method on Property, Plant and Equipment (PPE) and intangible assets, based on the Management assessment of the expected pattern of consumption of the future economic benefits embodied in the PPE and intangible assets, without any change in the remaining useful life of the assets. Consequently, the charge of depreciation for the year ended 31st March, 2026 is lower by ₹ 737.02 lakhs with a corresponding impact in the Profit Before Tax (PBT) and an impact of ₹ 551.51 lakhs in the Profit After Tax (PAT) on account of change in the depreciation method.

28.18.8 Dividend will be treated as an appropriation from Reserves & Surplus during the period in which it is approved by the Members. No provision is being made in the accounts for the current financial year in respect of dividend recommended by the Board after the balance sheet date.

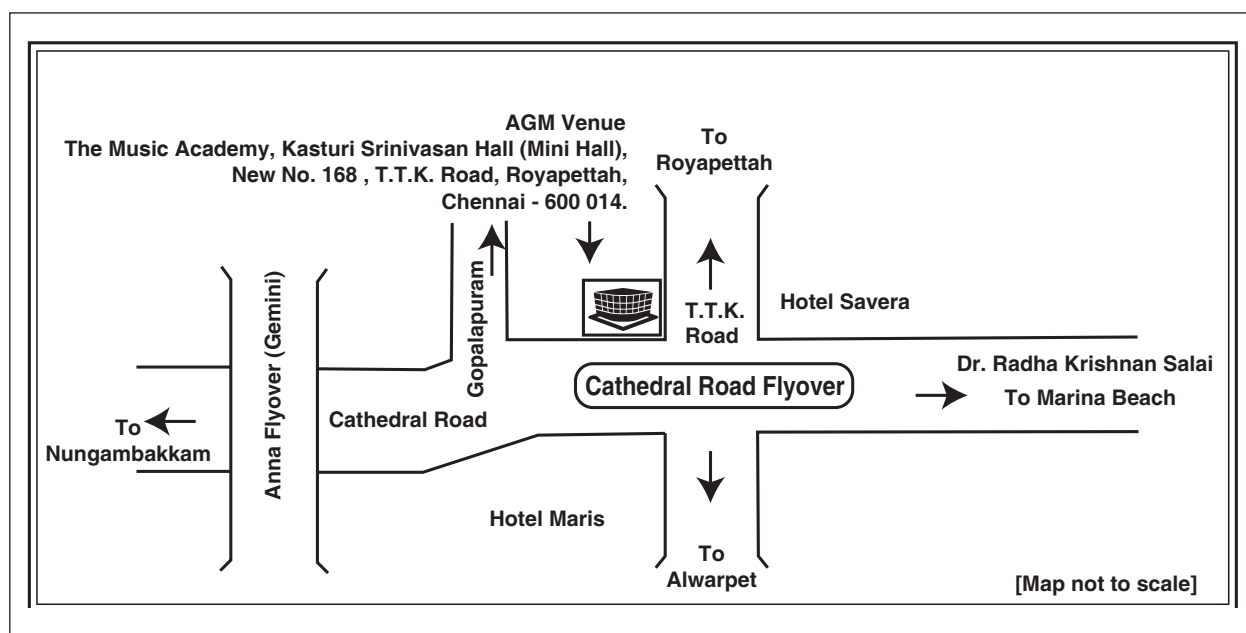
