The reason stated by Mr. Vijay Kumar for his resignation is as follows:

Mr. Vijay Kumar is being considered for appointment as a Whole time Director of M/s Sify Technologies Limited. As per Regulation 17A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, a person who is a Whole-time Director in a listed company cannot serve as an Independent Director in more than three listed entities.
